Served as part of the litigation team that successfully litigated the North Pacific Fisheries Council’s Amendment 113 governing the catching and processing of cod and halibut in Alaska and the Aleutian Islands, resulting in Amendment 113 being overturned.

Appx. ---, 2017 WL 6146939 (9th Cir. Dec. 8, 2017) (memorandum op'n).

24th Street Improvement Project Litigation. Assisted litigation team representing the City of Bakersfield in return to writ proceedings, which resulted in the Superior Court dissolving the writ of mandate and injunction in October 2016, and a judgment in favor of the City. Assisted litigation team in successful representation of City in writ proceeding initiated by Court of Appeal opponent seeking to enjoin project construction, resulting in the Court of Appeal denying the writ. The California Supreme Court denied review on February 6, 2017.
