### Texas Department of Transportation Projects

The project closed in August 2020. During procurement, Josh assisted with drafting procurement documents and preparations for closing and also advised TxDOT in connection with proposer meetings, responding to proposer questions and negotiating interagency agreements with stakeholders.
- **North Tarrant Express Segment 3C.** Key member of the legal team that advised on the negotiation and closing of a change order to add a \$750 million expansion segment to the Facility Agreement for NTE Segments 3A & 3B. Josh assisted with preparations for commercial and financial close and the drafting and review of ancillary closing documents. Financial close for the change order was reached in August 2019. The project was awarded the 2019 "Americas Project of the Year" in the road category by IJ Global.
- **I-35 NEX Central Project.** Key member of the legal team advising on the procurement of a proposed \$1.5 billion design-build-maintain project for the design, construction and maintenance of I-35 from the I-35/I-410 North interchange to FM 3009 and of connected portions of I-410 North and Loop 1604. Josh's duties involve assisting with drafting procurement documents, including contract documents, and advising TxDOT in connection with communications with proposers and negotiating interagency agreements.
